The vacancy position at Govt./Govt aided BAMS and BUMS institutions will be displayed on 21.10.2010 at the website of DMER. The preferences filled by the candidates during the preference form filling process (conducted during 06 July to 14 July, 2010) shall be treated as cancelled. During the above stated sessions, there will be personal counselling and allotment of seat to the eligible candidates as per the merit of MHT-CET 2010 and constitutional & specified reservation. The desirous eligible candidate (eligibility as per MHT-CET 2010 brochure) should present personally (Proxy not allowed) for Counselling and allotment of seat, along with all the original documents and one set of attested photocopies of the same as given in MHT-CET 2010 Information Brochure Page No.10. If the candidate has already taken the admission to any course, he/she should bring a certificate from the institution, stating that the original certificates are retained by them.

Following candidates are not eligible for this personal counseling round.

- a) Open category Candidate securing less than 50% marks in HSC PCB (40% for constitutional reservation candidate)

- b) Candidate who has already joined to health science courses as per MHT-CET 2010 admission process and filled status retention form.

At the end of each day of allotment process, the vacancy position will be displayed on the website of DMER.

The candidates should join the allotted course **upto 31st October, 2010** along with all the original documents and necessary fees. It will be the responsibility of candidate to submit the original documents at the time of admission. The **cut-off date** for **BAMS & BUMS Courses is 31st October, 2010** as per CCIM, New Delhi.
