#### **Personal Counseling Process of PGD-CET 2015 for State Quota admissions to Dental Postgraduate Courses (MDS) in State of Maharashtra**

In compliance to the Hon'ble Supreme Court of India, order in writ Petition(s) (civil) No(s)76/2015 dated 24<sup>th</sup> March 2015, there will be extended 3<sup>rd</sup> round of online allotment process from 9<sup>th</sup> May 2015 to 19<sup>th</sup> May 2015, under 50% All India Quota - 2015. The Vacant All India Quota seats of MDS will be surrendered to State of Maharashtra on 30<sup>th</sup> May, 2015 (After 5.00p.m.).

In view of the above stated round of 50% All India Quota seats, the schedule to fill State Quota seats by Personal Counseling round will be as per below stated schedule.

Eligibility /Not Eligibility criteria's for Personal counseling round will be strictly as per rule 13.4.1 and 13.4.2 of PGD-CET 2015 brochure.

**Saturday** : Those who have secure and joined from 50% All India Quota  
**30/05/2015** postgraduate admission process in colleges situated in State of  
**Up-to** Maharashtra should resign & surrender their seat on or before 30th  
**5.00 p.m.** May, 2015 so as to be eligible for aforesaid Personal Counseling round.

**Sunday** : **Combined Display of following Vacancy**  
**31/05/2015** 1) Non Allotted / Non-Joined / Resigned seats of state quota after 1st  
**After** round.  
**1.00 p.m.** 2) Non Allotted / Non-Joined / Resigned seats of 50% All India quota  
returned to State Quota up to 30/05/2015.  
3) Unallotted PH quota seats.  
4) Unallotted In-service quota seats if any.  
5) Newly created seats if any.  
6) Seats surrendered by Private Institutions.

**Monday** : **Submission of Status Retention form at respective institute.**  
**01/06/2015** • Candidates who have been allotted postgraduate seats in 1st and or  
**upto** 2nd round of PGD-CET 2015 and so far not filled the Status Retention

5.00 p.m. form and wish to retain the allotted seat should submit the Status Retention form on or before 1st June 2015.

- All those candidates, who have joined during 1st or 2nd round and submitted status retention form within prescribed date; will have to submit cancellation to the respective institute on or before 1st June, 2015, so as to be eligible for personal counseling round. Candidate attending personal counseling round without surrendering seat, will not be allowed to attend the personal counseling round.

The selection process will be according to the rules of PGD-CET 2015. All the desirous candidates who are eligible as per the rules should attend the personal counseling round according to the above schedule. The candidates should bring all the original documents for verification as per the rule no. 12.4 of PGD-CET 2015 information brochure.

Candidates who have already joined a PG Course through PGD-CET 2015 and not submitted status retention form should bring a certificate issued by Dean/Principal of the institute where he/she has joined, stating that the original certificates have been retained by them.

Candidates should note that they have to confirm the admission immediately after allotment of seat by paying Rs.1500/- in cash as admission fee and deposit all the original documents at the time of personal counseling.

The cut off date for PGD-CET 2015 admission is 10<sup>th</sup> June, 2015 hence any seat remaining vacant at Private Unaided Medical Colleges who opted admissions through PGD-CET 2015 can be filled at institute level on the basis PGD-CET 2015 Merit List from 4<sup>th</sup> June to 10 the June, 2015.
