**Admission Process of MHT-CET 2009 for MBBS & BDS Courses
(PERSONAL COUNSELING ROUND)**

The vacant seats of MBBS/BDS course at Government / Corporation colleges will be filled by personal counseling on 31st October 2009, as per the directives of Hon'ble Supreme Court in WP (C) 420/2009, dated 23/10/2009. The desirous eligible candidates are invited to attend personally (proxy not allowed) as per their State Merit List No. and Category, as per the following table.

The candidates who are **NOT ELIGIBLE** to appear for this personal counseling round are set out as under.

- (a) The candidates who have not filled the preference form for MHT-CET-2009.
- (b) The candidates who have once, selected but Not Joined / Cancelled (MBBS / BDS course).
- (c) The candidates who have filled Retention Form in any of the previous centralised admission round for any Health Science course.
- (d) Candidate who have already taken admission to either Medical or Dental course at Government / Corporation or Private institution.

The eligibility of candidates determined and/or decided at the time of preference form filling, will only be considered as per rule 4.12 of Information Brochure (Health Sciences) MHT-CET-2009. The vacancy position for this personal counseling round will be displayed on DMER's website by 28/10/2009. Candidates are requested to go through the vacancy position before attending this round.

The selection process will be according to the rules of MHT-CET 2009. All the desirous candidates who are eligible, should attend the personal counseling round according to the above schedule. The candidates should bring all the original documents for verification as per the rule no. 7 of MHT- CET 2009 information brochure. (except those who have already joined in any academic course)

Candidates who have already joined any academic courses should bring a certificate issued by the institute where he/she has joined, stating that the original certificates have been retained by it.

In the personal counseling round allotment of seat will stop after allotment of last seat. During this round, preference(s) given by candidates previously will not be considered for allotment of seats. Candidate should complete the admission process upto 5/11/2009 by paying the fees and depositing all the required original documents. It is sole responsibility of candidate to submit the original documents to the selected institute by 5/11/2009.
