ADVERTISEMENT FOR THE POST OF DIRECTOR

The Government of Maharashtra has constituted as per Government Resolution No.HNF-2016/C.R.99/16/Drugs-1, Dated 04 July, 2016 an expert selection committee to select a suitable candidate for the Post of Director by nomination/deputation.

The main object of the institute, registered under the Societies Registration Act, 1860 is to study and improve means of preventing and curing communicable diseases and to conduct research and training in related fields. The Institute now wants to fill up the post of Director, who is its executive Head, functioning under the supervision of the Medical Education & Drugs Department of the Government of Maharashtra.

As per the advertisement for this post dated 18/11/2016 the last date for application is 18/12/2016 Now the said date is extended to 05/01/2017. Interested candidates, fulfilling the below-mentioned conditions should send their applications to reach **Haffkine Institute for Training, Research & Testing, Acharya Donde Marg, Parel, Mumbai-400 012, on or before 05th Jan, 2017 upto 3.00 pm.**

1. Educational Qualification :

a. Candidate who, possess M.B.B.S. degree of recognized university with a Medical Council of India, recognized post graduate degree in Parasitology, Microbiology, Pathology, Bacteriology, Entomology, Pharmacology and Biochemistry.

OR

b. Doctoral Degree either in Microbiology/ Bacteriology / Virology / Clinical Pathology / Biochemistry / Pharmacology / Toxicology / Epidemiology / Zoonosis.

2. Age :

Age not more than 50 years for open category (The upper age limit is relaxed upto 55 years, in exception cases, considering their qualification and experience) and 55 years for reserved category or any other age limit decided by the Government from time to time, unless already in the Government /Semi Government service.

3. Experience :

- a. The Candidate should have at least 15 years experience in research and teaching. The candidate should have published 15 original research papers in indexed scientific journals.
- b. At least 15 years experience in Administration of a Research Institute / Medical College in organizing & guiding advance research.

4. Scales of Pay & facilities :

- a. Rs. 37400-67000 Grade Pay 8900 + admissible allowances as per Government / Institute Rules.
- b. Rent free accommodation.

5. Other details :

- a. Preference shall be given to candidate already recognized as Post graduate Teacher of a Statutory University and / Or who has passed the Diploma in Hospital Management.
- b. The candidate appointed by nomination/deputation shall be on probation for a period of 2 years.
- c. The selected candidate if a medical graduate will be required to be registered with Maharashtra medical Council.
- d. A person appointed to the post of a Director shall be required to pass examinations in Marathi & Hindi languages according to the rules made by Government in that behalf, unless he has already passed or has been exempted from passing these examinations and should have passed MS-CIT/ equivalent or better Computer skills.
- e. The candidate appointed on deputation shall retire as per his parent organization's rules for retirement.
- f. Director appointed by nomination shall retire on attaining the age of 65 years.

Application of plain paper should give basic personal details, educational qualifications and experience. List of publications and papers published in indexed journals and attested copies of testimonials viz Degree, MMC Registration Certificate etc. must be enclosed.

Candidates working in Government or Semi-Government organization must send their applications through proper channel. Those who have applied for this post as per the advertisement published previously may not apply again. Their previous applications will be considered during this process also. However for any addition in the qualification, experience etc, they may resubmit again fresh application, if they want.

Any kind of canvassing will be a disqualification.
