NEET - PG/MDS 2018 Second Round & MoP UP Round for Admission to Medical/ Dental Postgraduate Courses (MD/MS/ Diploma/MDS) in State of Maharashtra

In Compliance to the Hon'ble Supreme Court of India Order in Writ Petition No. (C) 357 of 2018 dated 3/05/2018, the vacant All India Quota Postgraduate Medical/ Dental seats in Govt./Corp./ Central Govt./Aided Institutes will be surrendered to the State quota on 5th May, 2018 (after 5.00 PM).

This office has completed the first round of counseling process. At the end of first Round there are few Vacant seats. The schedule to fill vacant seats of Govt./ Corp./Central Govt./Aided/Private Unaided/Minority, Medical/Dental Colleges (50% State Quota, 35 % Institutional Quota and 15% NRI Quota) through Second Round and MoP UP round counseling will be as stated below :

10 th May, 2018 upto 5.00 PM	Prescribed cut off date of Resignation, for the candidates whom the seat is allotted in First round of State Quota. Candidate from All India Quota cannot resign/cancel a seat.
10 th May, 2018 upto 5.00 PM	Submission of status retention at respective Institute

15 th May, 2018 At 05.00 PM	Vacant seats of Private Unaided/ Minority Medical/ Dental Institutions will be transferred to Respective Institutions. The Dean/ Principal of the Institution shall carry out the admission for these vacant seat on the basis of Inter-se merit from the list of NEET PG/ MDS - 2018 eligible candidates as per the directions issued by the Competent Authority during Academic Year 2018-19.
16 th May, 2018 02.00 PM	Display of seat matrix for MoP UP round II on website (Applicable for Govt./ Corp./ Central Govt. Institutions only)
16 th May, 2018 08.00 PM	Display of selection list of MoP UP round II on website (For Govt./Corp./ Central Govt. Institutes only) All the selected candidates should note that, he/she has to report at Department of Physiology, Grant Govt. Medical College, Mumbai on 18/05/2018 at 10.00 AM for Joining. Newly Selected candidates should bring their original documents and DD/Cheque. Candidates already joined during previous round(s) should not go to the previously joined Institution for cancellation. Such candidates should directly report as stated above.
18 th May, 2018	Last date of joining/ cut off date at Govt. And Pvt. Institutions.

Instruction to Candidates :-

1. Any candidates who joins during MoP UP round, if desires to cancel/ resign a seat, such a candidate is liable for penalty of Rs.20 Lakhs as per rule No. 21.1 & 21.2. He/She will not be eligible for admission through state Quota for Subsequent two Academic Years.
2. Vacant seats of Private Unaided Medical/ Dental, and Minority Colleges after 5.00 PM on May 15th 2018 will be filled by the Institution. For this CET Cell will publish the list of waitlisted candidates on the website.
3. Candidate who resigns their seat at Govt./Corp. Central Govt. Institutions, after 5.00 PM of 10th May, 2018 will have to pay a penalty of Rs.10 Lakhs for Non completion of Junior Residency/ Course as per rule No. 21.1 in addition to Rs. 10 Lakhs for lapse of seat as per rule No. 21.2 of information Brochure of NEET PG/ MDS 2018. If such a candidate resigns after 5.00 PM of 10th May, 2018, even after paying Rs.20 Lakhs, he/she will not be eligible for admission through state Quota for Subsequent two Academic Years.
4. Any candidate who resigns their seat from Unaided Private/ Minority Medical/ Dental college after 5.00 PM of 15th May, 2018, will have to pay three years fees as a penalty as per Rule No. 21.5 of Information Brochure.
5. Any candidate selected in MoP UP round(s), fails to join or resign after joining to an allotted seat, then such a candidate will have to pay penalty as per rule No. 21.1 & 21.2, as well as he/she will not be eligible for admission through state Quota for Subsequent two Academic Years.
