### Postgraduate Medical/ Dental NEET-2018 Admission Process

#### Reference - Hon'ble High Court Order in W.P. No.1814/2018 Dated 22/02/2018

As per Notice of this office dated 16/02/2018 the online submission of application for NEET Postgraduate Medical/Dental course was started from 16/02/2018. As per this notification Non-Domicile of Maharashtra candidates were not eligible to apply. However as per the above referred judgment in W.P.No.1814/2018 dated 22/02/2018, the Hon'ble High Court has directed to accept the online application form of Non-Domicile candidates completing MBBS/BDS Course from the State of Maharashtra. As per this judgment necessary changes have been made in the admission process, which are as follows.

1. The last date for online submission of application from is now extended from 26/02/2018 to 03/03/2018 (up to 5.00pm).
2. The last date to make payment in SBI through challan (generated online) is now extended from 28/02/2018 to 06/03/2018.
3. The above mentioned extended schedule is applicable to all the desirous Eligible candidates.

All the candidates should note that the rest of the eligibility and other conditions mentioned in the Brochure remain unchanged.

The window of online application will be closed on 03/03/2018 at 5.00 pm and no offline application will be accepted for further process of admission. Candidate should see the instructions/notifications on the website for further admission process. No separate or individual intimation is sent at any time till the end of admission process.

All the admissions pursuant to the judgment dated 22/02/2018 passed by the Hon'ble Bombay High Court in Writ Petition No.1814/2018 will be subject to decision of the Hon'ble Supreme Court in proposed proceedings to be filled against the said judgment by the State of Maharashtra in the Hon'ble Supreme Court.
