Instructions to Physically Disabled Candidates : All Qualified Lower Loco-motor Disabled/ Persons with Disability (PWD) Category Candidates of NEET PG-2017/ NEET MDS-2017 are advised to get themselves examined before Document Verification Process at Medical Board constituted at **All India Institute of Physical Medicine and Rehabilitation, Mumbai**. However Medical Board Issued by authorized other three medical institute as mentioned in NEET PG-2017/ NEET MDS-2017 brochures will also be treated as valid. Disability (PWD) certificate should be obtained in advance. Candidates who have attended this Medical Board, should remain present alongwith the disability certificate Those who have obtained disability certificate for All India Quota PG admission 2017 from authorised Medical Board can produce the same disability certificate at the time of Document Verification process. It is mandatory to bring disability certificate. Candidate without disability certificate will be considered as Non PWD candidate. No extra time period will be given for submission of Medical Certificate.

Candidate should bring following documents/certificates:-

- 1) Original certificates and a set of attested photocopies as stated in NEET PG-2017/ NEET MDS-2017 Information brochure.
- 2) Information Brochure of NEET PG-2017/ NEET MDS-2017 containing the process, subject and college combination codes etc. which is available to candidate on website of DMER i.e. www.dmer.org and www.mahacet.org
- 3) The candidates who have passed from Govt./ Corporation Medical College(s) and have completed internship on or before 31st March, 2015 must bring either bond release certificate issued by Directorate Medical Education & Research, Mumbai or receipt of penalty amount paid for the bond service, on the day of Document Verification (as per rule no.8.13 of NEET PG-2017 Information Brochure). Candidates who fail to produce such certificate/s at the time of Document Verification, will not be eligible for Online Preference Form filling Process under any circumstances.
- 4) Candidate who has already taken admission elsewhere through NEET PG-2017/ NEET MDS-2017/ other PG admission process conducted by Competent Authority should bring the selection letter issued by DGHS, New Delhi / Competent Authority and a certificate from the Head of the Institution mentioning the list of Original Certificates retained by the Institute. Candidate will have to submit attested photocopies of all the documents.
- 5) The selection list will be declared on 15th April, 2017 by 8.00pm. It will be displayed on the website www.dmer.org and www.mahacet.org.
- 6) Candidate should report to the selected colleges directly. No separate selection letter is necessary .
