**Personal Counselling Process for admission to newly permitted Audio Speech and Language Pathology Postgraduate Courses (MASLP) of State Quota Seats of Maharashtra.**

**Ref: Letter No. MED-1018/C.R. 339/18/Edu-2, dated 23.10.2018.**

In view of extension of cut-off date to 31.10.2018 for admission to MASLP Courses in State quota seats of Maharashtra State, it has been decided to conduct Centralized Personal Counselling Process on Monday, 29.10.2018. During this process admissions to newly permitted Audio Speech and Language Pathology postgraduate courses at below mentioned colleges will be carried out. The seat distribution is as follows:

**A) General Instructions and procedure for personal counselling process -**

1. All the desirous candidates who are eligible as per the rules of PGASLP-2018 Information and Preference Form Brochures, should attend the personal counselling round according to the above schedule. **Proxy will not be permitted.** The selection process will be according to the rules of PGASLP-2018 as stated in the respective information brochure.
2. The candidates should bring all the original documents for verification as per the Rule No. 8 of PGASLP-2018 information brochure of preference system. Candidates without original documents will be held Ineligible.
3. Candidates should note that they have to confirm the admission immediately after allotment of a seat by paying Rs. 1500/- in cash as admission fee and deposit all the original documents at the time of personal counselling, along with paying one-year tuition and other fees by cheque. The submission of original documents and payment of fees will be at the counter of the Institution at the site of counselling.
4. The amount of tuition fee of college and subject is available on the website. A candidate not paying the one-year tuition fee and other fee by cheque on the Spot will not be considered as admitted.
5. No extra time will be given for paying tuition & other fees and for deposition of original documents. Candidate asking for extra time will be held ineligible for opting a seat.
6. All the candidates opting a seat during this round have no option of resigning or non joining. If they do so, then penalty mentioned in the brochure will be applicable.
7. Candidate whose name is not in State Merit List should not attend this personal counselling process.
8. Candidate coming after 11.30 am at the venue mentioned above will not be considered for admission process.
9. If seats remain vacant after Personal Counselling round, they will be surrendered to respective college on 29/10/2018 after 8.00pm.

**B) Procedure for Institutional Round for MASLP Courses**

1. Institutional Round is for seats remaining vacant after centralised personal counselling round.
2. All the candidates having admitted status on or before 29.10.2018 are NOT ELIGIBLE for institutional round.
3. For institutional round eligible and interested candidates should approach to the Dean/Principal of the respective colleges within prescribed time and submit application in person. Such type of applications should not be submitted in the State CET CELL/DMER in person or email. Such type of applications submitted in State CET CELL/DMER will not be considered valid for any institutional level admission process.
4. At the time of admission during institutional round a candidate should submit all original documents along with requisite fees during prescribed time limit.

5. The list of eligible candidates for the institutional round will be published on the website on 29/10/2018 after 08.00 pm.
